



# **North Side Housing Feedback Results**



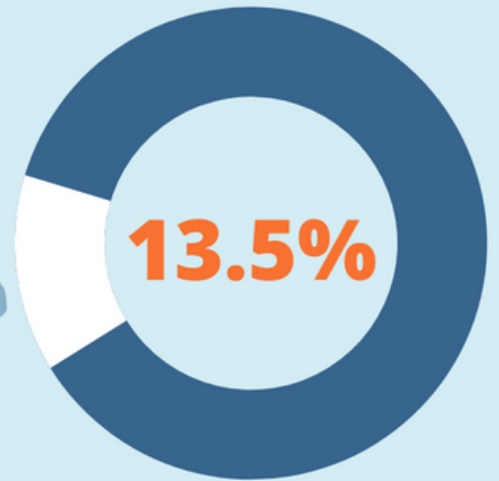
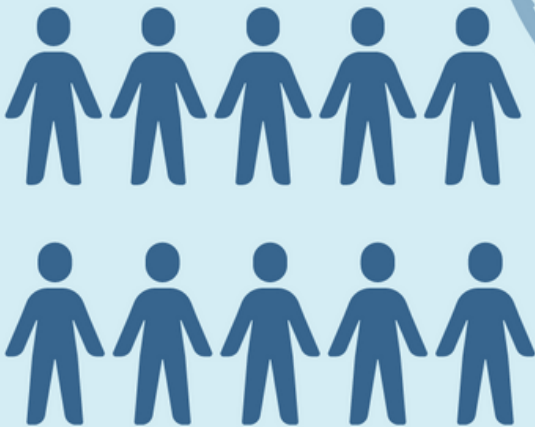
**North Side Housing and Supportive Services is seeking a special use permit to relocate its emergency shelter to 7464 N. Clark Street. The site is currently zoned as B3-3, which allows for emergency shelters with a special use permit.**

**Following a community meeting on June 21, the 49th Ward solicited feedback on the proposal from neighbors via an online survey. Constituents also provided feedback over the phone, by email, and during the meeting. The feedback survey was open June 24 through July 8.**

**On the following pages you will find the results of that feedback, which received the highest volume of any survey the 49th Ward has issued. The data is broken down by aggregate responses, respondents from within the ward, respondents within 4 blocks, respondents farther than 4 blocks respondents within 2 blocks, respondents within 1 block, respondents from outside the ward.**

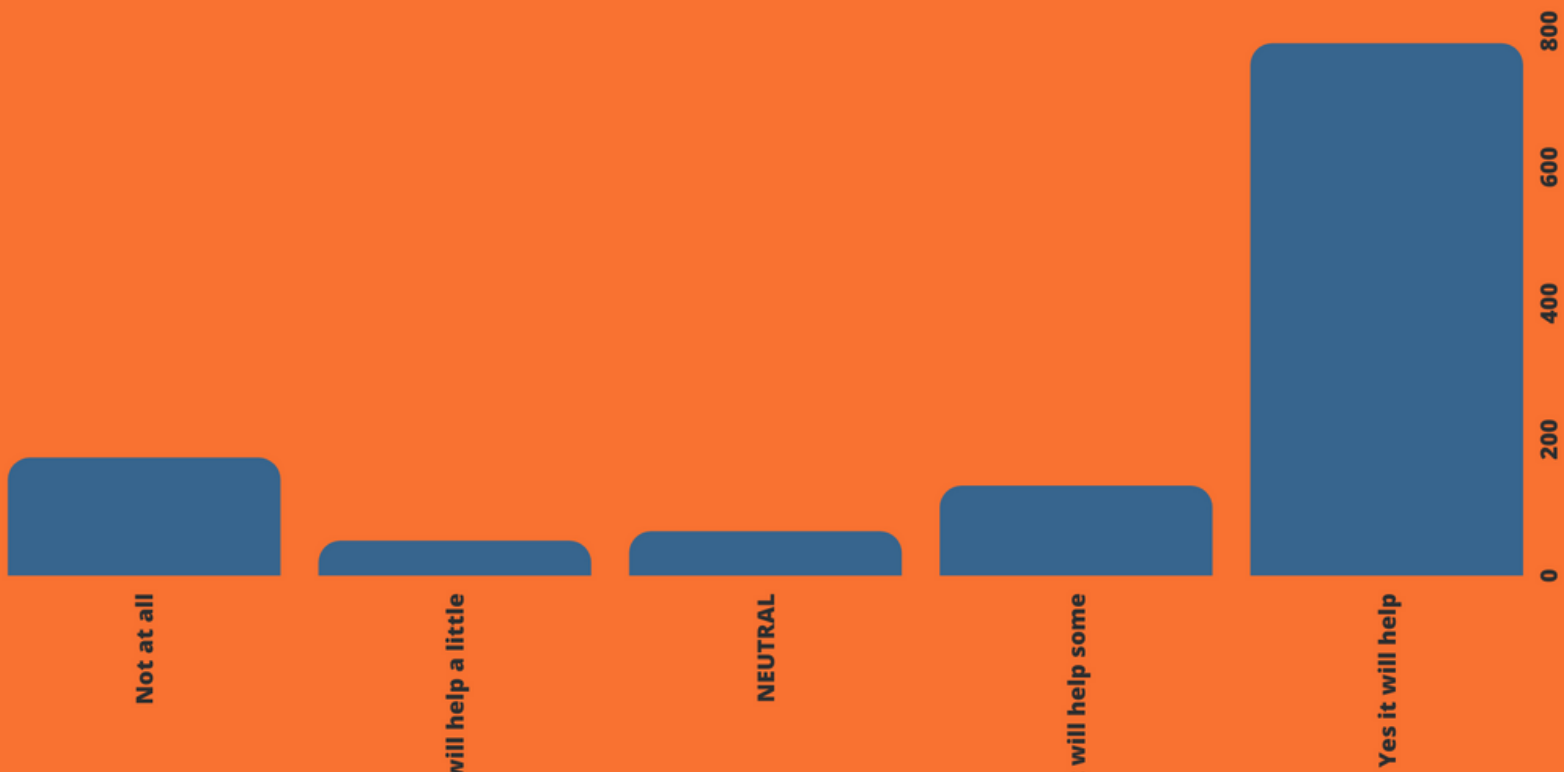

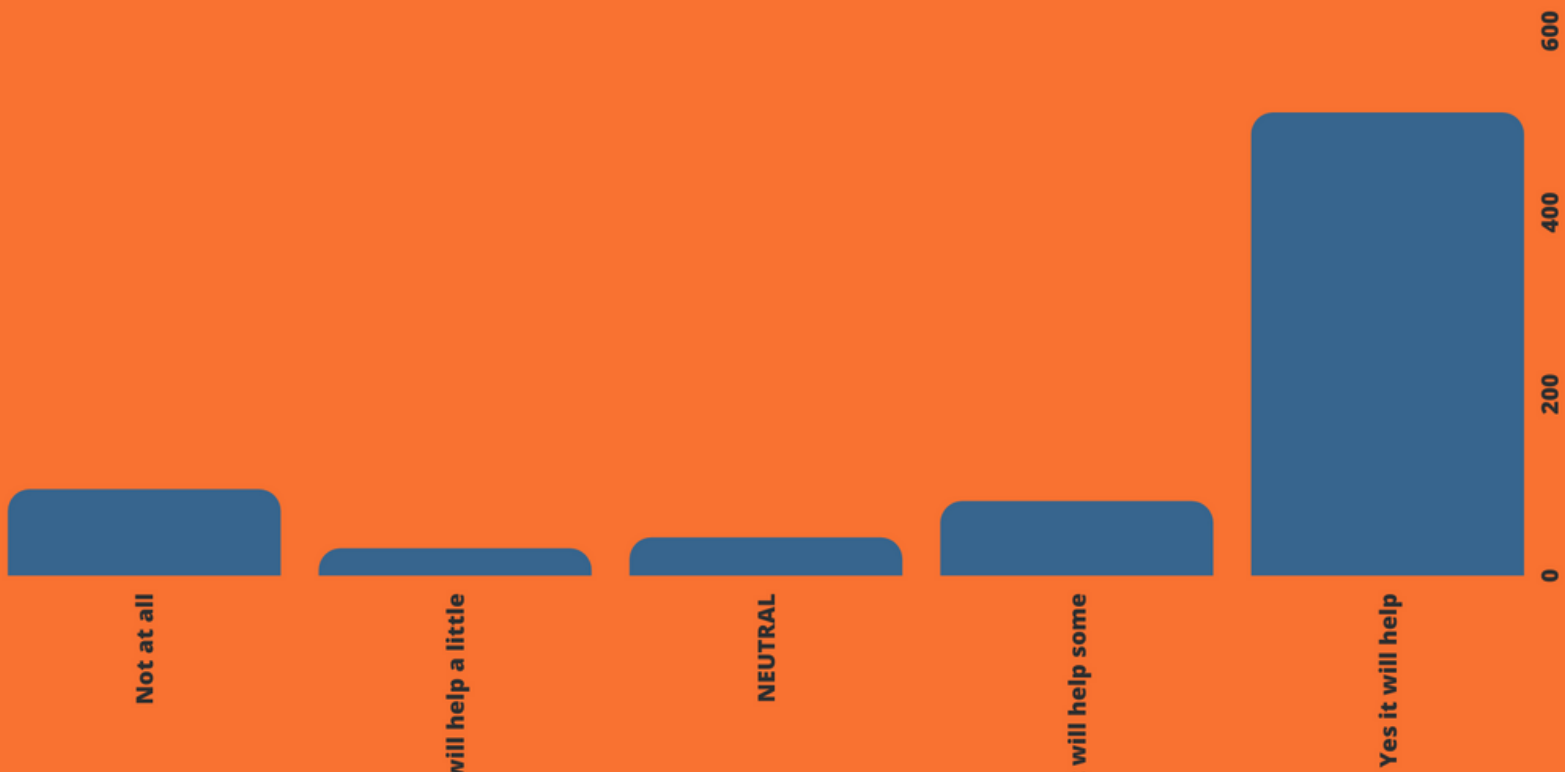
# RESPONSES FROM FARTHER THAN 4 BLOCKS (BUT STILL WITHIN THE WARD)
